

### **CRRSAA Grant Details**

Emergency Financial Aid Grants to Students under the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA)

1. PC AGE Career Institute (PC AGE) acknowledges that on March 31, 2021, the institution has received funding under the CRRSAA section 314(a)(4) program to provide Emergency Financial Aid Grants to Students
2. PC AGE has received \$307,671.00 in total for CRRSAA funds for student Aid from the Department of Education pursuant to the Certification and Agreement (for) Emergency Financial Aid Grants to Students.
3. PC AGE has distributed \$92,617.00 to students under the CRRSAA (a)(4) program as of June 30, 2021.
4. There were **46** estimated total number of students at the institution that are eligible to receive Emergency Financial Aid Grants to students under the CRRSAA (a)(4) program.
5. The total number of students who have received an Emergency Financial Aid Grant to students under the CRRSAA (a)(4) program were **46** students.
6. PC AGE has determined that all students who are or could be eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965, as amended (HEA), may receive emergency financial aid grants.

PC AGE has determined that all students who are eligible for Pell grants, federal or state need-based aid, are enrolled in distance education, and who need assistance to pay for their tuition fees due to the COVID-19 pandemic will receive an equal amount of \$2,000 each.

### **ARP Grant Details**
